# Important information for investors under the Australian Government's Significant Investor Visa (SIV) program

If you don't hold a subclass 188 visa under the SIV program, you don't need to read further.

We're writing to let you know that we're reducing the range of products we offer that comply with the Australian Government's SIV requirements for visa applications lodged before 1 July 2015. This means that from 31 March 2017 the following funds (Funds) will no longer meet the SIV program criteria:

If you hold a subclass 188 visa under the SIV program and are relying on your investment in a Fund to meet your visa conditions, we understand this change may be inconvenient. We sincerely apologise for this.

## What do you need to do?

If you don't hold a subclass 188 visa under the SIV program, you don't need to take any action.

If you **do** hold a subclass 188 visa under the SIV program, please take the following actions:

 Seek migration advice, such as from your migration agent, about what this change means for you and your visa. This is very important because it's your responsibility to comply with your visa conditions. We will not be liable for any consequences if you don't take action in response to this letter.

Under your visa conditions, we expect you'll need to redeem your investment in the Fund and make a new investment in another fund that meets the criteria of the SIV program before 31 March 2017. It's our understanding that you must complete your investment in the new fund within 30 days of redeeming your investment in the Fund. Please seek advice from a migration agent on the timing of switching investments.

2. Contact us to obtain a Form 1413, 'Declaration in relation to managed funds', in relation to the compliance of the Fund with the SIV program criteria.

We also recommend that you speak to your financial adviser.

## 您需要做什么?

# 如果您不持有在 SIV 计划子类 188 签证,您不需要采取任何行动。

如果您**持有 SIV** 计划下子类 188 签证,请采取下述措施:

1. 通过向您的移民代理等寻求移民建议,了解此项变化对您和您的签证有何影响。鉴于您有责任遵守您的签证条件,寻求上述建议非常重要。如果您不对本函件采取任何行动,我们将不对由此产生的后果承担任何责任。

在您的签证条件下,我们预计您将需要赎回您在基金中的投资,并在 2017 年 3 月 31 日之前在其他符合 SIV 计划标准的基金进行新投资。我们理解,您必须在赎回您对基金的投资后 30 天内完成对新基金的投资。请向移民代理咨询变更投资的时间。

2. 就基金是否符合 SIV 计划标准, 可联系我们获取《Declaration in relation to managed funds》的 1413 表格。
