


# **Antares Voting Record**

### Introduction

This document publicly discloses the voting record of Antares Capital Partners Ltd trading as Antares Equities ("AE") – Investment Manager for the period of 1 July 2023 to 30 June 2024 inclusive. The voting information in this document has been prepared in accordance with the disclosure obligations in FCS¹ Standard No. 13: Voting Policy, Voting Record and Disclosure ("the standard").

## **Important Information**

Where possible, AE does not apply different voting decisions to different schemes. To maximise the influence of our vote and for practical reasons, we vote consistently across all schemes where AE has direct voting rights.

This means that we apply the same voting decision taken on every (domestic listed company meeting) resolution to our entire shareholding across these schemes.

It is for this reason that in this report we disclose voting decisions on an "Operator level" (AE) and resolution level, rather than each individual Scheme (portfolio) and resolution level. This record covers voting decisions taken on behalf of all schemes operated by AE where AE has direct voting rights for predominantly Australian listed companies. This also includes X2 conjoined institutional mandates, and 1 segregated institutional mandate.

On this basis, only voting decisions taken on behalf of the following schemes/mandates are included in this report.
